Tracy informed the team that a committee of Fox C-6 counselors, social workers, teachers, parents, students, and administrators came together to review the nationally-recognized competencies and create goals and grade-level objectives to support the social and emotional development of our students. The framework was designed to be specific to the needs of our students and schools and to align with the values of the Fox C-6 community.
